

# Declaration of Compliance

with the requirements of Delegated Regulation (EU) No 886/2013

Article 9 of Delegated Regulation 886/2013, which pertains to the implementation of Action (c) of Directive 2010/40/EU requires that road infrastructure operators, service providers and radio broadcasters specializing in road and traffic information, both public and private, must communicate to the designated national bodies a statement of their identification information and a description of the information service(s) they provide, and must also submit a declaration of compliance with the requirements listed in Articles 3 - 8 of the above-mentioned Directive.

This declaration must be submitted before the 1<sup>st</sup> of October each year to the Agence Française pour l'Information Multimodale et la Billettique (AFIMB) – Tour Sequoia – 92055 LA DEFENSE Cedex.
